## Law Enforcement Retirement Bill Heard by Committee

County sheriffs and representatives of police unions presented **LB 427**, a proposal for a revised retirement plan for county law enforcement officers, to the Nebraska Retirement Systems Committee on March 25. Last week the committee heard **LB 426**, a proposal for a retirement plan for law enforcement officers in first-class cities. In prior years, city and county proposals have been combined into a single bill.

LB 427 would increase total employer and law enforcement employee retirement contributions to 16 percent of income in

October 2009 and 18 percent in 2012. Total contributions by the county and other county officials and employees would remain at 11.25 percent of wages. A committee appointed by the NACO president reviewed the proposal and the NACO board voted to oppose the bill due to concerns about cost and inequity with other county officials and employees.

Although LB 426 was designated as a Retirement Committee priority bill, neither measure has been advanced from committee.

## Snapshots of County Issues

• **Jail Reimbursement:** The Revenue Committee advanced a bill to combine funds currently appropriated for county jail reimbursement, state aid to counties and County Property Tax Relief into a single program. A committee amendment would delay implementation of the program from 2009 to 2011. **LB 218** was introduced at NACO's request and designated as a Speaker priority. A listing of priority bills of interest to counties appears on the reverse.

The Revenue Committee also killed several bills to provide or eliminate sales tax exemptions.

• **State Assessment:** Furniture, computers and other equipment

used by the Department of Revenue in state-assessed counties would be transferred to the county when the assessment function is returned to counties under a proposed amendment to **LB 121**. The amendment also addresses payment for leave and health insurance for transferred employees. The bill, which was prioritized by Sen. John Wightman, is on Select File.

• **Motor Vehicle Titles:** Motor vehicle dealers could apply for a certificate of title under a proposed amendment to **LB 202**. The bill, which provides for electronic titles if a lien has been filed, is on Select File and is a Transportation and Telecommunications Committee priority bill.

## Register for Legislative Day, Equalization Workshop

County officials can register on the NACO website ([www.nacone.org](http://www.nacone.org)) for two upcoming events. On April 16, all county officials are invited to meet with their senators and observe the Legislature in session. Registration begins at 8:30 a.m. at the NACO office. Governor Heineman, Speaker Flood and several committee chairs will address county officials in the morning. After a luncheon with senators, participants can visit senators and state agency offices, view floor debate, and

tour the Capitol and Governor's Mansion.

On May 14, NACO will host a County Board of Equalization Workshop in Kearney. A tentative agenda includes sessions with representatives of the Tax Equalization and Review Commission and Property Tax Administrator, as well as guidance from an appraisal specialist and several county officials, including a former county attorney involved in a recent Supreme Court decision on exemptions.

## No Legislative Report Next Week

Because debate next week will focus on bills with limited county impact, no Legislative Report will be issued next week.

The Legislature will be in recess on March 27 and 30. Full days of debate will begin on March 31.
